**FLAT FEE HALF-DAY - \$850 per Party\* FLAT FEE FULL DAY - \$1,700 per Party\***

### NORMAL SCHEDULE

**HALF DAY AM** is 9 AM to 1 PM / **HALF DAY PM** is 1 PM to 5 PM

**FULL DAY MEDIATION** is 9 AM to 5 PM

**“ADDITIONAL TIME”**: Beyond scheduled session is billed at \$200 per hour\*/ per party.
